2.1.2 Average percentage of seats filled against seats reserved (Average of last five years)

- The institute offers B. Pharm and M. Pharm programmes in four specialization subjects, Pharmaceutics, Pharmaceutical Quality Assurance Techniques (QAT), Pharmacology and Pharmaceutical Chemistry. The Programmes are approved by AICTE, Pharmacy Council of India and Savitribai Phule Pune University.
- The admissions to B. Pharm and M. Pharm course are made through Centralized Admission Procedure run by **Government of Maharashtra, State Common Entrance Test Cell, Mumbai on the basis of MHT-CET/NEET score (For B Pharm)** conducted by the Government of Maharashtra, Admission Regulatory Commission and State Common Entrance Test Cell, Mumbai and on the basis of **Graduates Pharmacy Aptitude Test (GPAT) score conducted by All India Council for Technical Education, New Dehli (For M Pharm)**.
- Admissions for these programmes are made as per the directives of **State Common Entrance Test Cell, Mumbai, Maharashtra State**.
- As per norms, 80% of the total seats are filled by the competent authority through **centralized admission process (CAP)** and 20 % seats (management seats) are filled at the **institute level (IL)** by the institute.
- The seats for reserved category are **earmarked only under CAP (80% of total seats)**. The seats are reserved for the candidates belonging to backward categories belonging to Maharashtra state.
- Percentage of seats reserved and seat distribution matrix for reservation is given in Information Brochure published by State Common Entrance Test Cell, Mumbai for each year's admission and is available on the website www.cetcell.mahacet.org.
- The percentage of seats reserved as per State Common Entrance Test Cell brochure is as follows:
