Subject: Regarding seed money for students projects

Respected Sir.

Our students Ms. Isha Ghadge, Mr. Saurav Kulkarni and Ms. Namrata Rathod (all from TY B harm) have undertaken a research project titled "Sanigreen- Eco friendly and compostable sanitary pads". The project aims to develop a sustainable solution to environmental hazards caused by sanitary pads. A prototype of the same has won Second prize at Young Pharmacist Innovative Project Award and First prize at Ideathon 202. Both were national level competitions. We are aiming to develop this further in view of filing patent and technology development/transfer for industrial scale. The work will involve materials, travelling and processing cost.
