◆ AREAS EXPLORED

□ CHANGING ROOM -

It is the first place where the employee enters. This area is used by the staff members to change their clothes and get dressed in an appropriate dress code to enter the production facility. Apron, hair cap, gloves, mask, footwear are used by the staff which are sterile and are present in the changing room.

□ WAREHOUSE -

This area has direct access from the changing room. It is the systematic storage of medicine and its related products. It is one of the most important departments in a pharmaceutical industry as all the imported raw material and goods like API's, excipients, packaging materials, labels are weighed and stored in allotted rooms. There are various and separate rooms for storage of different materials like API, excipient, packaging material, finished product, volatile products and these are maintained according to their requirements.

□ PRODUCTION

The APIs and excipients which are stored in the warehouse are then sent to required production facilities such as liquid orals, tablets or capsules. A register is maintained for the

same. SOPs are followed. Production plays a major role in manufacturing of pharmaceutical products. The production area should be sterile and maintained. Various equipment were present such as granulator, fermenter, rotator, compressor, fluid bed dryer and many such equipment which are required during the manufacturing.

□ QUALITY ASSURANCE

After the production of pharmaceutical products it is tested for its efficacy and quality of product. This is done before packaging and marketing of the product. It is an important step as it assures the quality and efficacy of the product or API or excipients. It helps in the production of the best quality of pharmaceutical products. Errors such as analytical error, production error, operational error can be identified and rectified with the help of Q.A and helps in quality control of product. Various instruments are used such as Ph meter, magnetic stirrer, spectrometer, autoclave, leak test apparatus, dissolution test apparatus, disintegrating apparatus.

□ PACKAGING

Packaging is done with the help of various machines and can also be done manually. Filling, sealing, and packaging is done in this area.

Primary package- bottle, caps

Secondary package- labels etc

Tertiary package- cartons, barrels

These materials are used for protection of products and maintain their integrity and quality.

CONCLUSION

From my internship at Emcure Pharmaceuticals Pvt. Ltd., I was able to get practical knowledge and understanding about the instruments and GMP for the production of various pharmaceutical products such as tablets, capsules and liquid oral.
