- 1. ICH Guidelines (Q8/Q9/Q10) and Document Verification to meet quality attributes.
- 2. History and development of Validation technology and benefits of validation including critical quality attributes. He told about approved validation process and preparing the report of validation.
- 3. Validation Life cycle was explained in a simplified manner. Different types of validation like Prospective, Concurrent and Retrospective validation were discussed in great details.
- 4. He told about the notifications given by the Regulatory Bodies in a timeline.
- 5. He discussed about Drug Master File (DMF) with all the 7 sections involved in it.
- 6. He also discussed about parts of ANDA.
- 7. Stages of Process Validation and variability were explained. Factors which impact output variability were especially discussed.
- 8. He explained about on-going sampling during different phase of commercial production.
- 9. Process optimization techniques were discussed.
- 10. Process Life Cycle was critically explained.
- 11. He told about sampling plans and process stability and capability with CPK intervals.
- 12. Parameters for CPP and COA were discussed.
- 13. Process Design, and Process Qualification was summarized


The explanation was in a very simplified language and it was thoroughly enjoyed by all the participants.

- 4. Structure interpretation using different techniques IR/NMR/Mass with major focus on interpretation of 2D NMR was the gist of the lecture.






- 1) Vaibhav had chosen guidance by the way of conversation.


Session by Mr. Ulhas Karkhanis :
