Short Summary of received Feedback:

1. Questions cover all areas of working of institute eg. Curriculum, teaching-learning-evaluation, facilities, administrative support, research culture etc. Question pertaining to NSS is only for B.Pharm. whereas question pertaining to thesis is only for M.Pharm. The score is on a scale of 1-5.
2. The minimum score obtained for Fairness of internal evaluation systems is 3.59 at M.Pharm. and 3.38 by B.Pharm. for employability skill improvement.

Action Taken:

1. The average score for all parameters is more than 70%. The efforts must be continued to improve the score.
2. Low score of 3.38 (out of 5) by B.Pharm for the parameter related to life skills/employability skills may be improved by organizing Personality Development sessions for B.Pharm. class. Students to be made aware of Grievance redressal mechanism during orientation and stressing its importance.
