

Questions cover all areas of working of institute eg. Curriculum, teaching-learning-evaluation, facilities, administrative support, research culture etc. Question pertaining to NSS is only for B.Pharm. whereas question pertaining to thesis is only for M.Pharm. The score is on a scale of 1-5.
The minimum score obtained for infrastructure facilities(Classroms, laboratories, library and sports facilities) is 3.76 at M.Pharm. and 3.61 by B.Pharm.

Action Taken:

1. The average score for all parameters is more than 70%. The efforts must be continued to improve the score.

2. Low score of 3.44 by FY-TY for the parameter related to life skills/employability skills may be improved by organizing guest lectures on varied relevant topics for these classes.
